Come to this weekend's Dearborn Homecoming event, even though I have been a 30-year Homecoming widow. Thank you Dearborn Public Schools for allowing me to participate in your administrative training seminar. It's football season and I am feeling a little Schadenfreude regarding troubles in Columbus. My wife let me attend two major league baseball games, during a recent trip. You have a wife who "allows" you to attend two games during a trip. Have a good excuse for missing a Rotary event because I am picking-up my kids from camp. Dearborn Planning Commission turned down a request to build a six-story hotel behind Village Plaza, 50' from a residential subdivision, and in close proximity to existing commercial development. Dearborn Homecoming includes a car show, Fishing Derby, Bee Gee's Tribute Band, and fireworks (try watching from West Dearborn parking deck roof).

Today's program was annual report on Dearborn Rotary Foundation by Dale Bender, CPA. Maysam Allie-Bazzi introduced Dale, who has both BA and MSF from Walsh College. He is a Past Dearborn Rotary President, state-licensed securities and insurance representative, been a CFO and Comptroller in private industry, 10-year treasurer of Dearborn Area Chamber of Commerce, and also plays drums.

Dale said all Club members are members of Dearborn Rotary Foundation. It is the 501(c)(3) philanthropic arm of Dearborn Rotary Club. Foundation meets fourth Tuesday of every month and has a seven-member board. It began with a bequest from estate of Otto Rowen, a Dearborn Rotarian, and retired Dearborn educator. Dale provided all attending, Dearborn Rotary Foundation Combined Statement of Financial Position plus a 2017-2018 Dearborn Rotary Foundation Year in Review. Foundation was created in 1966 and assets have grown to \$1,185,000. It is astounding what our Foundation does. Foundation Board astutely manages the funds. Foundation gave away \$125,000 last year, but total assets grew by \$5,000. Foundation had its' annual audit and we are fine.

Foundation funds are segregated by use. For example, Archer Scholarship, which is funded by upcoming Golf Outing plus Spiratex Company, has grown to well over \$200,000. Existing portfolio, donations, and our fundraising activities support Dearborn Rotary Foundation. You are welcome to attend any Foundation meeting. Dale became Treasurer of Foundation in 1999. Spend about ten minutes of every Foundation Board meeting on financials. Jim Ives is Foundation Chairperson this Rotary Year. Board rotates annually with four most recent Club Past Presidents serving on the Foundation, plus three trustees, each appointed by a Past President, plus Treasurer Dale. Dearborn Rotary Foundation has given away almost \$1,265,000 since 1999. Charitable giving was 53%, scholarships 38%, and youth initiatives 9%. Foundation is self-sustaining and we are fortunate to have in place.

Dan Hogan, Jim Ives, Bob Gleichauf, Rick Goward, and Bob Ziolkowski all had questions or comments. Serving on Foundation Board is educational about Dearborn Rotary's outreach. We had to go through a lot of steps to become a 501(c)(3) organization. Other Rotary Clubs have foundations. Some Rotary Clubs are excellent fundraisers. Trenton and Taylor Rotary Clubs sponsor one-night events that attract 600 to 1,000 participants. Visit Dearborn Rotary website to find a request application to Foundation. Looking to improve our Website to make finding request application easier. Dearborn Rotary Foundation ideally likes fund requests to be first considered by Dearborn Rotary Club Board. Please attend a Club Board and Foundation Board meeting. We need general Dearborn Rotary Foundation funds because of restrictive nature of segregated funds, such as Otto Rowen Fund.

IRS regulations permit required IRA distributions for those over 70.5 years to be donated to a 501(c)(3), such as Dearborn Rotary Foundation, tax free. If you do not do required distributions, you can be subject to a 50% penalty and still pay required taxes. See Dale for more information.

Jim Thorpe said Foundation Board appreciates Dale's work. President Glenn thanked Dale for his presentation and Jim Thorpe for his work as Chairman of Foundation Board this past Rotary year. Glenn promotes Dearborn Rotary events, such as Scholarship Gala, via social media, such as Twitter.

Bob Gleichauf made a quick announcement of all volunteers and their roles at this Monday's Hugh Archer Scholarship Golf Outing. Dearborn Rotary Club meeting ended with us reciting the Four-Way Test in unison.
